CONDITIONS OF MEMBERSHIP AT THE LAKE JACKSON RECREATION CENTER

Entry: Membership cards must be valid and must be scanned at the Front Desk before entering the Lake Jackson Recreation Center. New cards are issued when enrolling in a new membership. A \$2.00 fee will be charged to replace membership cards.

Programs and Fees: The Lake Jackson Recreation Center offers a wide-range of fitness programs (Group X and Water Aerobics classes) for our members at no additional cost. Other programs/activities and special events offer discounts to Lake Jackson Recreation Center members. A complete listing of fitness classes and other opportunities can be found on-line or at the Lake Jackson Recreation Center.

Facility Closures: The Lake Jackson Parks and Recreation Department reserves the right to close all or any portion of the Lake Jackson Recreation Center for any reason. Fee refunds will not be issued, except in cases of extended full-facility closure.

Lost or Stolen Items: Members should not bring valuables, including money, onto the facility premises, lockers or parking areas. Each Member understands and agrees that LJPARD will not be liable for the loss, theft of, damage to, the personal property of Members or guests.

Locker Rooms: Members are discouraged from bringing valuables into the Recreation Center and we encourage everyone to store their belongings in locker in the Men's and Women's locker rooms. Lockers are available for daily use at no charge, but lockers must be emptied at the end of each day. Members must bring their own lock or may purchase one from the Front Desk for \$5.00. Locks left overnight will be cut and contents will be removed and held for 30 days. Members may also rent lockers for \$3 per month (3-month minimum). Please ask Front Desk for a rental application. Locks will be issued with rental agreement. Lost or stolen locks will be replaced for a fee of \$5.

Personal Training: No member may train or coach other Members (as determined solely by the LJPARD) or engage in any type of business or commercial activity while at LJPARD facilities unless they register as a Personal Trainer. For more information on registering as a Personal Trainer contact the Front Desk.

Behavior/Drug Policy/Membership Suspension and Termination: No drugs, alcohol, smoking, weapons, violence, profanity, or other inappropriate behavior or violations of Lake Jackson Parks and Recreation Policies and Procedures is permitted. Members must comply with all posted rules; all City, State, and Federal laws, rules, or regulations; Parks policies; and staff instructions. Failure to do so may result in temporary removal from the center, suspension or termination of membership.

ADDITIONAL TERMS AND PROVISIONS

- Children 18 years and older must be carried on your income tax to be listed as an immediate dependent.
- Due to scheduled programs/activities and repairs/maintenance, access may be limited to components of the facility.
- No fee reductions will be made for changes or discontinued classes or services that are provided at no additional charge.
- All classes, rooms, parking and equipment are available subject to demand and may be crowded at peak hours or may be discontinued or times changed if demand fluctuates.
- I understand that myself and those listed as immediate dependent family members are participating at our own risk to injury, and neither the City of Lake Jackson, Parks and Recreation Department nor its affiliates carry insurance to cover my immediate family or me. Insurance is the responsibility of the individual participant.
- I hereby, give permission that any audio and/or visual images captured of me or my immediate family members during regular activities at the recreation center through audio, photo, and/or video means will be used solely for the Parks' promotional material, multi-media, and publication purposes without further permission and any compensation.
- The Lake Jackson Recreation Center DOES NOT REFUND MEMBERSHIPS, nor are promotional memberships eligible for a refund.

Lake Jackson Parks and Recreation Department reserves the right to amend the conditions of the membership and the rules and regulations without prior notice.
