The following positions are up for election in the 2024 General Election for a two-year term:

- Mayor
- Councilmember Position No. 2
- Councilmember Position No. 4

### **CANDIDATE INFORMATION**

Qualifications for Office:

- Shall be at least twenty-one (21) Years of Age
- Shall be a resident citizen of the City of Lake Jackson
- Shall be a qualified voter of the State of Texas
- Shall have been such a resident of the City of Lake Jackson for not less than twelve (12) months preceding the election
- Shall not be indebted to the City of Lake Jackson

Qualified residents seeking to run for an elected office for one of the open positions in the City of Lake Jackson must complete an [Application for a Place on the Ballot for a General Election](#) and submit it to the City Secretary's Office.

## **CAMPAIGN FINANCE REPORTS**

Reporting requirements and other regulations are set out in Title 15 of the Texas Election Code (Ch. 251-259) and the rules adopted by the Texas Ethics Commission. Officeholders, as well as candidates, are subject to regulation under Title 15. Officeholders, as well as candidates, are required by state law to file campaign finance reports (Form C/OH) with the City Secretary's Office. Reporting requirements end when a candidate has filed a final report with the City Secretary.
