AGREEMENT FOR USE OF CONSTRUCTION DUMPSTER

I, _____, hereby contract with the City of Lake Jackson, Texas to rent a construction dumpster.

Based on container size charge per pull (pick-up & return):

MINIMUM CHARGE:

You will be charged for a minimum of one pull per calendar month, whether or not the container was serviced.

INITIAL CHARGES:

Before the construction dumpster is placed at the desired location, the Initial Set Fee of **\$144.00**, and a deposit of **\$_____** must be paid. Your deposit will be applied towards your final invoice.

OTHER CHARGES:

- Trip Charge \$144.00
- Relocate \$144.00
- Cleaning Charge \$100.00
- Landfill waiting fee of \$95/hour, if applicable

OTHER INFORMATION:

____ If a hard surface does not exist to set the dumpster on: The customer must lay two (2) pieces of lumber (2" x 2' x 10') on the ground, then place scrap lumber under the front legs of the construction dumpster.

____ Dumpsters cannot be filled more than 1/3 full with heavy/dense materials such as concrete, dirt, shingles, etc.

_____ All dumpster requests should be given at minimum a day before service is needed. Dumpsters are serviced on a first come first serve basis. In the event that the day you are requesting is booked we will do our best to complete your service on the next available day.

_____ If your organization has been approved to provide the city with PO numbers in lieu of prepayment, please keep in mind that **payment will be due THIRTY DAYS from the date of the invoice.**

_____ If providing PO numbers we also ask that you provide the city with a correct billing address, accounts payable contact and phone number in the spaces provided on page one of this contract.

_____ To request a dumpster pick up, please call the City of Lake Jackson Public Works Desk at (979) 415-2430.

_____ Please email dumpster contracts to inspections@lakejacksontx.gov .

_____ If dumpster bill is not paid by 2 p.m. on the due date, a penalty of 10% of the unpaid balance will be applied to the account. Full payment including penalty charge is due within 14 days to avoid dumpster being removed. Payment can be made by mail, in person at the office during normal business hours, by check or money order in the night drop box (located by the drive thru window) or via the website at www.lakejackson-tx.gov. All credit card transactions will incur a 3% convenience charge.

_____ If a balance remains unpaid over 45 days, the account will be terminated. Payment of the final balance and an additional deposit will then be required to reinstate the account.
